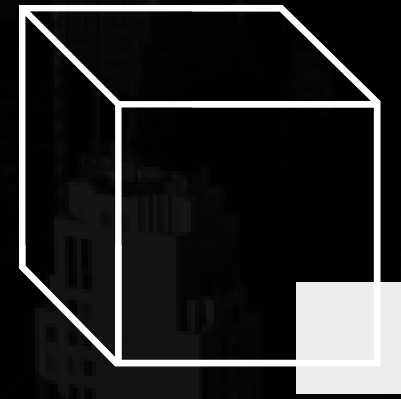

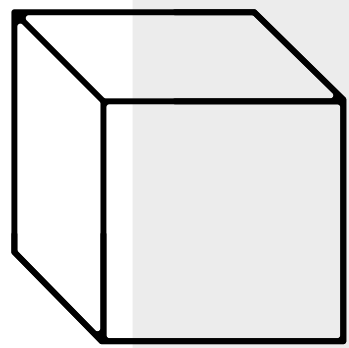

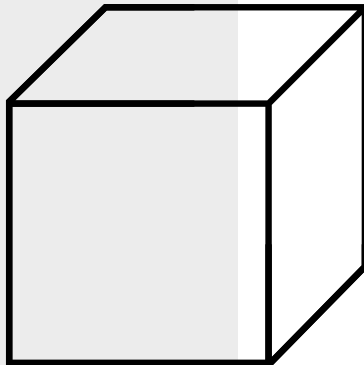

What is Portugal Residency Visa?

The Portugal golden visa is a residence by investment program. It enables non EU investors to make a qualifying investment to live in Portugal.

Portugal's passport is the 6th strongest passport in the world. The diverse culture, serenity and economic development over the years embarking people to invest and live there. It is a place for tourist attraction. The country launched golden visa program in 2012, within the 8 years, 1000+ people have got their golden visas.

- ▲ Medical certificates proving excellent health of the applicant and dependents
- ▲ Personal net worth must be high for 5 years

Buying Property In Portugal

The Portugal Golden Visa program has proven to be the most popular scheme in Europe with investors attracted to its flexibility and benefits. Launched in 2012 the investor visa program has been actively promoted internationally by the Portuguese government. An investment of €500,000 (or €350,000 reduced option) in real estate in Portugal will gain a residency permit for a family including dependent children. The golden visa can be renewed every two years providing the applicant spends two weeks in the country every two years.

Reduced Investment Option

It is possible to obtain the golden visa through a reduced investment option of €280,000 and €350,000 into real estate requiring renovation. Such projects need to be approved by SEF as qualifying for the reduced investment amount and it is critical to ensure the right project and legal advice is obtained before embarking on such investment.

SPANISH RESIDENCY BY INVESTMENT

Spanish Residency By Investment allows you to and your family to live in Spain and do anything you like to do with freedom- you can study, work, set up your business or just enjoy free time. Besides, you get a great opportunity to travel around European Union without a Visa.

Benefits of BlackStone Spanish Residency:

- ▲ The main applicant should comply with a moderate number of requirements set by the immigration authorities in Spain. A foreign investor is not supposed to take a test assessing their Spanish language, culture, history and traditions,
- ▲ In accordance with the rules of the residency by investment programme, you need to apply for your whole family.
- ▲ Your application will be considered within a short period of time. That allows you to obtain your residence card within 2 or 3 months under normal conditions; now, this period has been extended to 4 or 5 months because of the coronavirus pandemic.
- ▲ In Spain, unlike in other countries, the fact of acquiring a residence card does not mean that you must remain in the country all the time. A short visit to Spain will suffice.

BlackStone Golden Visa for Spain

Spanish Golden Visa is granted to an investor for 365 days or for half a year if you have decided to invest in real property but your deal has not been formally established yet. Nevertheless, that is still a simple visa in your passport and not a residence card. When you hear about a fast procedure of obtaining residency by investment, it is about the Golden Visa. Another advantage of this type of visa is that you can get it in your home country, in a Spanish visa centre.

Within 6 or 12 months you and your family members will need to go to Spain and apply for residency. In Spain, investors are granted residency for 2 years and they can extend it for additional 5 years.

So if you are currently staying in Spain, you can immediately apply for a residence card. If you make investment staying in your home country, you have the following options:

- ▲ You can obtain the Golden Visa and go to Spain to apply for residency afterwards.
- ▲ You can apply for a short-term visa, go to Spain and apply for residency by investment.

Eligibility Criteria for BlackStone Spain Investor Visa

- ▲ An applicant should be at least 18 years old.
- ▲ An applicant should have evidence that they have enough legally sourced finances acquired outside the Spanish Kingdom to be used for investment.
- ▲ The main applicant and their dependents that are of age are expected to provide a criminal record certificate for the last 5 years. They are also expected to have committed no violations of immigration laws.
- ▲ A prospective investor and their family should be in good health. They are also expected to have a health insurance policy issued by a private or state-owned company authorised in Spain.

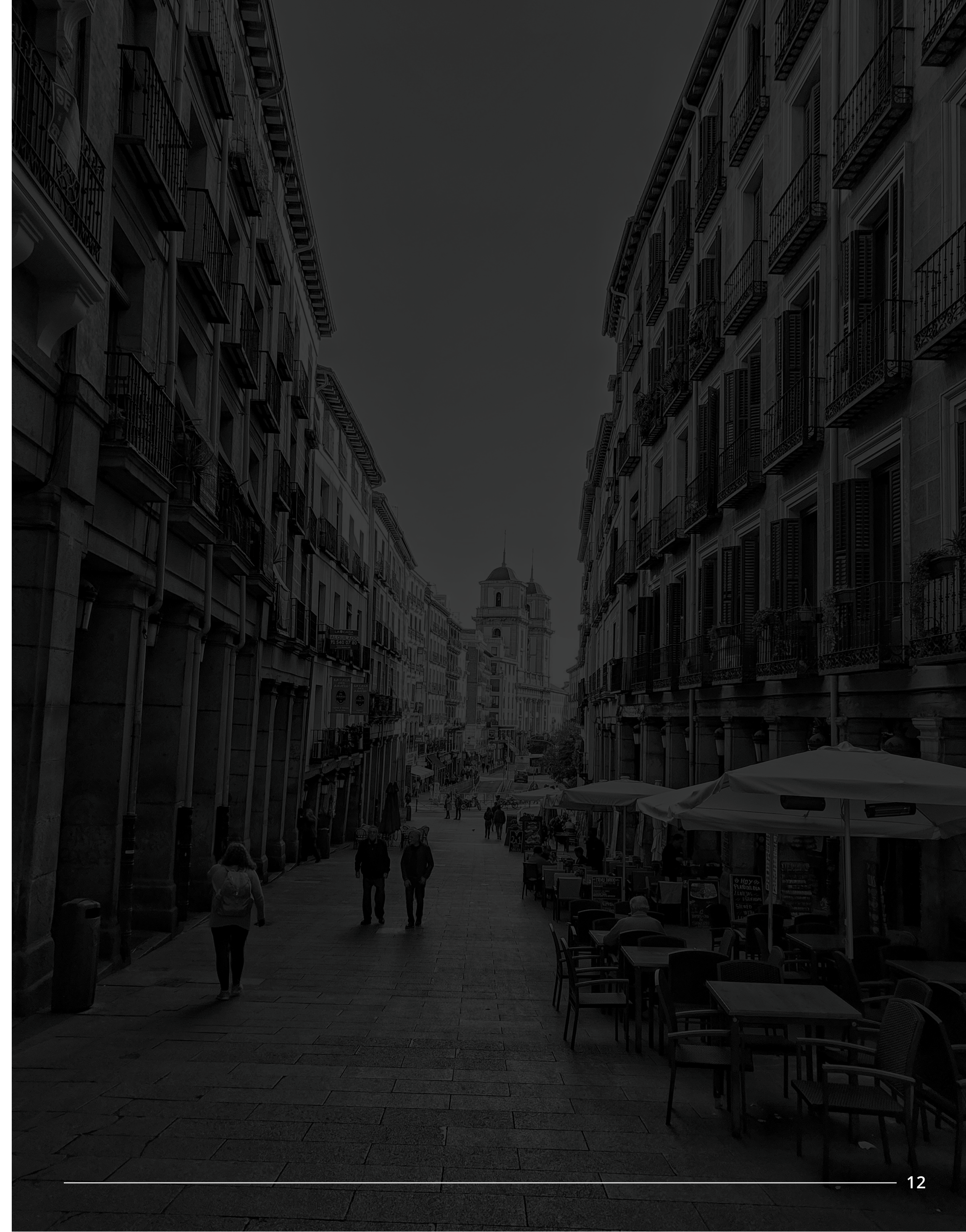
